1. I will be at least thirteen (13) and under eighteen (18) years of age the year I compete in the Miss Austin Texas Teen Pageant
2. I am not married, have never been married and have never had a marriage annulled. I have never given birth to a child and am not now pregnant nor am I a parent. If any of these conditions change, I will notify my Director immediately, and I understand that this may affect my eligibility.
3. I am of good health and moral character.
4. I am a naturally-born female and am a citizen of the United States and at least one of the following is true: (a) I now reside and have resided in the Central Texas Area as my permanent and primary residence for a period of at least six (6) months immediately prior to the beginning of the Miss Austin Texas Teen Pageant (although I may have attended a college or university elsewhere); or (b) I have resided in the Central Texas Area as a full-time student at a college or university for one entire semester immediately prior to the beginning of the Miss Austin Texas Teen pageant, and I am continuing to reside in the Central Texas Area as a full-time student (although I may have spent or be spending the summer in another city or state).
5. I agree that if I participate in the Miss Austin Texas Teen pageant I will abide by all rules and regulations governing the pageant.
